### Legislation

### RECENT DEVELOPMENTS IN BREED SPECIFIC LEGISLATION (BSL)

**Liverpool, England:** Under Liverpool, England's Dangerous Dogs Act, prohibited animals that have not caused harm can go through a process to be spared destruction. The condition of exemption is that owners have third-party insurance for their pets, which costs around £25 a year.

Twenty-two "exempt" banned-breed dogs were seized in March 2014 in Liverpool because they were uninsured. Officials stated this action was taken to protect residents against "irresponsible owners" who had failed to ensure that mandatory third-party insurance was in place. Warrants were executed to seize the pets, and they were put down within a matter of hours. High Court judges in Manchester have since ruled that the seizure and destruction without court permission was "unlawful," and the force may have to pay out compensation to the pets' owners.

Debbie Gogarty, 45 told the ECHO how she begged officers not to take away her family pit bull Ruben after she forgot to renew the insurance. She said: "The police came in and took Ruben straight away. They wouldn't even let us say goodbye. It was just a mistake. Everyone has things going on in their lives and can make an oversight. Every year Ruben was insured, this was the one time he wasn't. He didn't deserve to die for the sake of £25."

**Camdenton, Missouri:** Misty Brown purchased a house in Camdenton. Before closing on the house, she checked with city hall and was told by an employee that her registered American Bulldogs were fine because they were not pit bulls. Despite doing her due diligence, despite American Bulldogs not being a targeted breed, and despite the fact that the dogs did nothing wrong, Brown was cited two weeks after moving into her new house for violating the ban after a neighbor complained about the dogs. Brown was ticketed and told that she had to get rid of the dogs.

The 1989 ban defines a "pit bull" several ways:

"A pit bull may be identified as any dog which exhibits those distinguishing characteristics that substantially conform to the standards established by the American Kennel Club or United Kennel Club as described in the identification checklist which is on file in the City offices."

- 1. Staffordshire bull terrier breed of dog;
- 2. The American pit bull terrier breed of dog;
- 3. The American Staffordshire terrier breed of dog;
- 4. Any mixed breed of dog which contains <u>as an element of its breeding</u> the breed of Staffordshire bull terrier, American Staffordshire terrier, or American pit bull terrier as to be identifiable as partially of the breed Staffordshire bull terrier, American Staffordshire terrier, or American pit bull terrier;
- 5. Any dog which has the <u>appearance and characteristics of being predominantly of the breeds</u> of Staffordshire bull terrier, American pit bull terrier, American Staffordshire terrier; <u>and other breeds</u> <u>commonly known as pit bulls, pit bull dogs, or pit bull terriers, or a combination of **any** of these breeds." (original law enacted 1989)</u>

Thus, the law has 2 separate and very different standards: The language (1) an element of its breeding and (2) substantially conform are both used. Both are different in what they mean legally. An element means <u>any</u> percentage of the specified breeds. "Predominantly" implies over 50%.

Below is the check list used to identify dogs as falling under the ordinance. This gives a chance to see exactly how broadly these descriptions can be interpreted.

- Head is medium length, with a broad skull and very pronounced cheek muscles, a wide, deep muzzle, a well defined, moderately deep stop and strong under jaw. Viewed from the top, the head is shaped like a broad, blunt wedge.
- Eyes are round to almond shaped, are low in the skull and set far apart.
- Ears are set high. Un-cropped ears are short and usually held rose or half prick, through some hold them at full prick.
- Neck is heavy and muscular, attached to strong, muscular shoulders.
- -Body is muscular, with a deep, broad chest, a wide front, deep brisket, well sprung ribs and slightly tucked loins.
- -Tail is medium length and set low, thick at base, tapering to a point.
- -Hindquarters are well muscled, with hocks set low on the legs.
- -Coat is a single coat, smooth, short and close to the skin.

### Legislation

When Brown approached the board, she was asked that she be allowed to keep her dogs because they were not pit bulls and their lineage as American Bulldogs is documented and provable. The board decided that because the registered American Bulldogs were determined to fit some of the physical description of a pit bull, that they were banned. The board seemed to think that they could define a dog's breed however they wish, based on 8 criteria that are extremely open to interpretation. Actually, not even 8, as a dog only has to meet 5 of the 8 criteria in order to be banned.

Brown and her attorney asked the board to review the ban and the board was told by the city attorney that there is no reason to do so. Obviously the city attorney does not know much about due process, and is perhaps not the best to be advising in this situation, as the law is clearly flawed. Brown's attorney stated that the town is subject to legal challenge for a vague law, and it appears that they will be heading to court over the issue. We do not know the status of the dogs.

This case highlights the exact opposite of what the pro-BSL lobby claims-- that only actual "pit bulls" are targeted under bans, and that other dogs are not targeted because "everyone" can identify a pit bull. If papers don't disprove a dog is banned, then there is no short-haired dog in the community is safe. They also claim that dogs aren't taken from their homes, and that bans simply keep new dogs from the community. Clearly, this is not the case.

**Aurora, Colorado:** In October, 2014, voters in Aurora, CO were given the opportunity to repeal the city's 9 year old breed ban, which had been discussed multiple times since the law's inception. Taking such a repeal to the voters was questionable because, once a ban is in place, most residents will have had very little personal interaction with the banned breeds and thus, are more apt to have to rely on media coverage as the basis for their opinions. And in this case, area media had not been terribly accurate in their reporting.

Voters in Aurora, prior to heading to the polls, were not advised of the following:

- 1. All national organizations with expertise in dog behavior support repealing breed bans. Every. Single. One. These organizations of professionals are basing their reputations on their opposition to breed-specific laws. And these organizations are very diverse, and include the Center for Disease Control (CDC), the National Animal Control Association (NACA), American Veterinary Society of Animal Behavior (AVSAB) American Veterinary Medical Association (AVMA), Association of Pet Dog Trainers (APDT), the American Society for the Protection of Cruelty to Animals (ASPCA), Humane Society of the United States (HSUS), and the American Bar Association all agree that laws targeting breeds are ineffective and should be replaced with laws targeting aggressive dogs based on their behavior, not their breed.
- 2. The 9 year old breed ban has NOT been effective at improving public safety or reducing dog bites. In fact, the number of bites in Aurora has actually increased by 77% since the law was put into effect and the law seemed reverse what was a trend of decreasing dog bites and bites immediately began trending upward after the law passed. In fact, the four highest years in total dog bites occurred AFTER the law was enacted to supposedly improve public safety. The total number of bite incidents has increased 77% since the passing of the ordinance back in 2006. It's also worth noting that the breed ban was set at addressing only about 15% of the dog bites in Aurora; it never attempted to address 85% of the cases. In spite of the total bite data being available, not one single media outlet in the Denver/Aurora area has decided to publish it.
- 3. Under the ordinance there has been the mass slaughter of more than 1,158 family pets that look like pit bulls at taxpayer expense. According to Aurora Animal Care, 636 pit bulls were killed in 2006 (the first year after the ban was passed), 173 were killed in 2007, and roughly 100 every year since then. The ordinance has led to the direct killing of more than 1,000 family pets at taxpayer expense since it was enacted.
- 4. Aurora City Council members that support the law have acknowledged that the law isn't about improved public safety and is not rooted in factual information. One Aurora City Council Woman told a news program in Denver: "Oh, you bet if I could, I would ban the owners too. By banning the dogs, we lose the violent behavior that comes with the owners." She then went on to say that breed bans make people feel safer. "It's not about a fact, it's about a feeling." Never mind that pit bulls are among the most popular breeds of dogs in the country, and owned by people of all races, income levels, and professions including lawyers, academics, and young professionals.
- 5. Taxpayer expense of managing the ordinance and the legal challenges to it has been substantial. In *one case alone,* which it eventually lost, the City of Aurora endured more than \$130,000 in legal fees associated with defending the law. The city also has been challenged in their breed identification of more than 100 dogs -- and ended up being wrong on their breed identification in <u>77%</u> of the cases. Again, all at taxpayer expense.
- 5. City officials have acknowledged that the original breed ban was a failure. The original law banned 10 different breeds of dogs back in 2006. in public safety. It's cost innocent pets their lives. It's cost taxpayers hundreds of thousands of dollars. And the council members who support the law acknowledge it's not rooted in fact, and only makes people feel better. And the law has no professional support.

In the Nov. 2014 election, voters in Aurora, by a 2-1 margin, upheld Aurora's breed ban.
