# Summer tips

## Fourth of July Tips for Pet Owners



For many dogs the Fourth of July is a traumatic day filled with flashes and booms. Extremely frightened dogs may run away. To keep pets safe, many professionals suggest the following:

Consult your veterinarian before the fireworks begin. Confirm that your pet is microchipped, and the contact info is current. Obtain any medications that might be helpful. Be sure your pet's ID tag is up-to-date and you have recent, clear photos of Fido in the event your dog is lost.

Exercise and feed your dog before the fireworks begin. Put Fido "to bed" early -- with a new chew bone or stuffed hard rubber toy. If your dog is crate trained, use it. If not, make sure your dog's bed is in a room where you can close the windows, turn on fans, a radio or TV to block out the noise and flashes of light.

DO NOT take your dog outside during the fireworks. You never know what might fly through the air and land in your yard or at your feet.

If your dog DOES need to go outside, make it a quick potty stop -- on leash (yes, on-leash, even in your own back yard) -- and then back inside. (You don't want to have to chase a frightened dog around the yard...and worse yet, you don't want your pet to escape in panic.)

DO NOT take your dog to a public fireworks display. You may think your dog will be fine, but it only takes a moment for something traumatic to happen. You suddenly have a frightened dog who may try to escape or act aggressively out of fear.

The next morning be sure to walk your yard and pick up any paper, plastic and other debris that flew through the air and landed in your yard.

If you feel that Fido is going to be too stressed, contact your Veterinary clinic this week and discuss options.

**Have a safe and sane Fourth of July with your four-legged friends.**

# Summer tips

## Heat Stroke

Dogs and cats can't perspire and can only dispel heat by panting and through the pads of their feet. If you suspect heat stroke in your pet, seek veterinary attention immediately.

**Signs of heat stroke include** *(but are not limited to):*

- Body temperatures of 104-110F degrees

- Excessive panting
- Dark or bright red tongue and gums
- Sticky or dry tongue and gums



- Staggering
- Stupor
- Seizures

- Bloody diarrhea or vomiting

- Rapid heartbeat

**Note:** Short-nosed breeds such as Bulldogs, Pugs, etc., large heavy-coated breeds, and dogs with heart or respiratory problems are more at risk for heat stroke.

## Cooling Your Pet

- Find some shade. Get your pet out of the heat.

- Use cool water, not ice water, to cool your pet (very cold water will constrict the blood vessels and impede cooling).

- Place cool wet cloths on feet and around head.

- Offer ice cubes for the animal to lick.

- Contact your your veterinarian.



# Summer tips



## DOGGONE, IT'S SUMMER!

Please keep your pets safe this summer. Dogs don't sweat like humans and can suffer **HEATSTROKE** far more easily.

Exercise your dog early or late in the day. All dogs, especially flat faced breeds can overheat quickly.



Check the temperature of the ground or sand because if it's too hot to touch, then it's **TOO HOT** for their PAWS.



Provide fresh water daily. Clam shell pools and doggy ice treats/kongs/home alone toys are great fun, keeps them cool and provides mental enrichment.



Leave dogs in a shady area, bearing in mind the movement of the sun as the day passes.



**Never** walk your dog when the temperature is over 30C (85F), their paws burn on hot pavement and hot sand.



**Never** leave your dog in a parked car on a warm day. Even on a cool day, the temperature in the car is much hotter than outside and can lead to brain damage or death!!



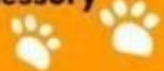
### SIGNS OF HEATSTROKE

Muddy pink gums (instead of bright pink), heavy panting with occasional frothing at the mouth, disorientation, increased heart rate.

**What To Do:** Remove the pet from the heat source if possible. Increase ventilation (fan) and apply cool water or a cool towel compress. Do not apply ice, this causes the blood vessels to constrict and takes the dog longer to cool down. Reapply the cool towels frequently. Offer water to your pet, but don't force it.

**Get your pet to the veterinarian quickly.**

**Dogs are not a disposable/fashion/status/breeding/profit-making accessory but a 10-15 year commitment, that will love you forever.**
