<u>Awards for Champions/Titles:</u> BCGS would like to award plaques annually for new Champions and Titles. Jeff Ryman is trying to locate the vendor that has the old cast of the BCGS medallion. Used to be located in Ballard. Mia found a plaque on Amazon for \$30 plus shipping. Will continue to look for better pricing. Let Tamara Marcotte know when your bulldog has achieved a championship or performance title.

<u>2019 Show Back to Red Lion:</u> For the 2019 show (to be help first weekend of August 2019), we are teaming up with OSBC for the specialty shows at the Red Lion. The cost will be split between clubs.

- Jeff and Winn Ryman have signed a contract and have made a \$300 deposit
- Jeff presented a list of judges and the list was narrowed down to three options. We will open up for more nominations and vote in May.
- Jeff and Beth (OSBC) are donating companion airline points with Alaska so if the judges are couples, it will help with costs.

Running with the Bulldogs Specialty Shirts: We spent \$1,901 on 105 Running with the Bulldogs shirts (\$1,327) and 50 Mosaic Bulldog shirts (\$574). To date, we have sold 52 Running with the Bulldogs shirts (incl. pre-orders) and 13 Mosaic Bulldog shirts for a total of \$1,785. Our profit is \$927 on those sales. Our remaining inventory of 90 shirts would provide for sales of \$2,435 with profit of \$1,270. We also sold 3 Slobberfest t-shirts at the SKC booth and we have 11 of those shirts remaining. We are posting flyers on Facebook and advertising with the Division clubs. Some people have been asking about another special order so they can get sweatshirts. Once we sell more of our inventory, we will look at this again. We would have to order 75-100 to get screen-printing and an acceptable price. Jeff Ryman is going to check with Gail and Ed Harris about taking the BCA Medallions and our shirts to the Denver and Utah shows to sell.

<u>Breeder Referral Program:</u> So far, there are 4 Breeders that have paid the fee, however we are still awaiting an application from one. Has the website been updated yet to reflect this? Also, the Breeder Referral Application needs to be revised. Dave Harrington will send this out once it's done.

2018 Specialty Show:

- Ribbon upgrade: Dlanor Kennels have said they will help pay for ribbon up grade. Cost is \$250 for the 2 days. It was decided to order them with no dates on them for the class placements but have dates for all others. This might save on costs for future years. Dave Harrington will order them this week.
- Trophies/Rosettes for PVDF Show: Do we want trophies for the PVDF show? If we do, they will provide rosettes. This is just for the BOB, BOS, BOW, WD, WB, RWD, RWB SD and SB.
- Supported Entry: We are a supported entry for this show. Jeff Ryman will notify the sponsoring club.
- Dog Dishes for Supported Entry: We will be supporting all 3 shows so 15 dog bowls are needed.
- Dave Harrington brought up the idea of getting some dog toys for all of the dogs that are entered in the show. Someone had done that at another show he was at and the dogs really enjoyed it. Some ideas were discussed but no decision was made.
- Dave Harrington sent out an email to members to ask for volunteers for all aspects of the show. He will update the list and resend.
- Show Funding Raffle/Auction Donations: Mia Carper, Cathy Harrington and Paula Brockway will work on putting together raffle baskets. If anyone would like to donate items, they can be brought to any meeting, show or event or you can contact any of the above. Raffle baskets and silent auction items will be on display at the show and then raffled and finalized at the picnic. Len & Trish Whitney have donated bulldog puppy throw pillows that can be used for fundraising. Melanie Trichler has donated an 8x10 custom print.
- 4-6 month Puppy Class: There will be a 4-6 month puppy class with Zack Lane as the judge.
- Show Advertising/Publicity: Melanie will be responsible for advertising the show.
- Trophies: Would like to do towels with our theme on them. Dave looking into the cost. Presenting the Linda Borden Memorial for Best Puppy on day one of the specialty show.
- Looking for volunteers to transport judges to and from the airport and show. Otherwise, judges' transportation used by WWC is Semper Fi Chauffeur and the cost is \$55 per judge per trip. Dave Harrington will put together a schedule of arrivals and departures to help with scheduling volunteers.
- Judges Gifts: Joan Johnson has volunteered to be responsible for Judges Gifts.
- Barbeque for Saturday: DeCoursey Park has been paid and secured as the venue for the BBQ. The cost is \$60 for a 10 am 3pm time frame. Club to pay for hot dogs and hamburgers. Need Volunteers to set up. BaRay will try to have the bulldog judging completed before 11:00.
- Insurance: Need a copy of the Insurance to give to the PVDF show secretary. Dave Harrington and Jeff Ryman have been provided a copy of the insurance policy.
- Premium List/Catalog: Need someone to work with BaRay on the show to set up timetables for premium list and catalog copy.
- Cleaning Deposit: Sandy Fisher sent the refundable cleaning deposit of \$150.00 and the EMT and extra table to Cindy Carriegan, Specialty Liaison.
- Hotel Reservations: Hotel reservations at the Fairfield have been made.

<u>Handling Class</u>: Jeff Ryman and Ashely Wall have put together a handling class. Handling Classes will be held to encourage conformation showmanship for Bulldogs and French Bulldogs. Free to all Bulldog Club of Greater Seattle and French Bulldog Club of Puget Sound members & guests. This class will be open to all levels and is intended to be practice for dogs and handlers needing ring time. New handlers, kids as well as puppies are welcome. Time: 7:30 – 8:30 PM Thursday evenings on May 10, 17, and 31 and June 7, 14, 21, and 28. Additional summer dates may be added based on continued interest and participation. Location: 8313 Riverview Rd, Snohomish WA 98290. Hosted by Jeff and Winn Ryman (25+ year Bulldoggers and AKC Bulldog Judges). BCGS Member Ashley Wall has graciously provided this location. This is a private residence and there are no restrooms available on site.

<u>Summer Picnic:</u> Ashley Wall offered her home in Snohomish for a picnic on August 25th. The Sammamish KC show is that weekend so would plan for the picnic/fun match to happen after bulldog judging.

Insurance Policy: The current insurance policy with Sportsmen's is set to renew in August. We need to look at other options to try and get the cost down.





Ambassador for Health Award Program

The purpose of the BCA Ambassador for Health Award program is to promote betterment of the Breed through health testing by recognizing Bulldogs, owned by BCA members, which have met specific health testing requirements.



Overview and Deadline:

Each eligible Bulldog will be awarded a certificate suitable for framing which indicates the level of achievement and details the health certifications the dog has successfully completed. Certificates will be awarded annually to all Bulldogs whose owners have submitted a completed application and the required verification to the Health Committee by the deadline date. In order to be recognized as an Ambassador for Health and/or Health Pioneer Award recipient at the BCA Nationals, completed applications must be received by the 1st day of the month immediately preceding the month in which that year's Nationals is scheduled. For 2018, because Nationals will be held in October, the application deadline is September 1.

Levels and Requirements:

<u>Bronze:</u> Successful completion of any four eligible certifications/DNA screenings
<u>Silver:</u> Successful completion of any five eligible certifications/DNA screenings
<u>Gold:</u> Successful completion of any six eligible certifications/DNA screenings
<u>Platinum:</u> Successful completion any seven eligible certifications/DNA screenings
<u>Diamond:</u> Successful completion of all eligible certifications/DNA screenings

Eligible Certifications:

OFA Congenital Cardiac (all certifications accepted, Echo preferred)
OFA Patellar Luxation
OFA Tracheal Hypoplasia
OFA Thyroid
OFA Elbow Dysplasia
OFA Hip Dysplasia

Eligible DNA based health screenings:

Hyperuricosuria (HUU) Type 3 Cystinuria DNA Marker

Passing results are required on all tests (passing is defined by OFA and an OFA certificate must have been issued) for the Ambassador for Health Award. All tests must be submitted to OFA and be part of their public database.

Age Requirements:

Congenital Cardiac, Patellar Luxation, Tracheal Hypoplasia & Thyroid:
Dogs must be 12 months of age or older on the date of the examination.
Hips/Elbow Dysplasia:

Dogs must be 24 months of age or older at the time of the radiography.

Ambassador for Health Award Program

The purpose of the BCA Ambassador for Health Award program is to promote betterment of the Breed through health testing by recognizing Bulldogs, owned by BCA members, which have met specific health testing requirements.



Application Requirements:

The Bulldog that is applying for the Ambassador for Health Award must be owned or co-owned by a BCA member in good standing. If the dog is co-owned, the co-owner who is a member of BCA must submit the application. It is not necessary to be a BCA member at the time the tests were performed.

All awards are designed to be a one-time award for each recipient, rather than a recurring, annual award. Additional levels may be applied for the next year provided all verification is received by the Health Committee by the deadline date and the recognition award will be given at the appropriate upgraded level.

Pioneers of Health:

In addition, any Bulldog receiving an Ambassador for Health Award that has also participated in any BCA-initiated or recognized health research project will also receive a Health Pioneer designation which will be included on their Ambassador for Health certificate.

- OFA EYE is considered part of the Health Pioneer recognition since at this time the Ambassador for Health program is comprised of permanent certifications. A passing OFA EYE certificate that is current the calendar year of the award is required. All tests must be submitted to OFA and be part of their public database.
- Certificates for BAER hearing testing, CHIC DNA repository and OFA Spinal Database may also be submitted for inclusion in the Health Pioneer designation.
- Proof of participation is required for any other BCA-initiated health studies in order to be included in the Health Pioneer designation.

The Health Pioneer can also be applied for as a stand-alone certificate. However, OFA EYE certification will not be considered for the stand-alone certification.




