**\* COMPLAINT PROCEDURES:** *Complaints of any kind resulting from the members of BCGS who participate in the BCGS Breeder Referral Program shall be sent in writing to the BCGS Secretary for investigation. Upon receipt of the written complaint against the breeder, the complaint will be forwarded to the Breeder Referral Committee (three (3) members with a minimum of one (1) Board Member) for review. The member in question will be provided a copy of the written complaint by the Committee. The investigation will take no longer than 90 days from the time the member is notified. The complaint and committee findings will be reviewed by the BCGS Board and results from said investigation will be provided to both parties. If the Breeder Referral Committee and the BCGS board believe that the complaint(s) are valid, they may recommend anything from a written warning to permanent removal from the Breeder Referral Program.*
